The Commission vide its Suo-Moto order dated August 30, 2018 commenced the proceedings for the Annual Performance Review for FY 2016-17 and FY 2017-18 and Aggregate Revenue Requirement for FY 2018-19. The State Distribution Companies, viz., **Dakshinanchal Vidyut Vitran Nigam Limited (DVVNL)**, **Madhyanchal Vidyut Vitran Nigam Limited (MVVNL)**, **Paschimanchal Vidyut Vitran Nigam Limited (PVVNL)**, **Purvanchal Vidyut Vitran Nigam Limited (PuVVNL)** and **Kanpur Electricity Supply Company Limited (KESCO)** have made presentation and submissions for Determination of Aggregate Revenue Requirement (ARR) / Tariff for FY 2018-19, Annual Performance Review for FY 2017-18 and True Up for FY 2015-16 & FY 2016-17. The State Transmission Company, viz., **Uttar Pradesh Power Transmission Company Limited (UPPTCL)** has made presentation and submissions for Determination of Aggregate Revenue Requirement (ARR) / Tariff for FY 2018-19, Annual Performance Review for FY 2016-17 & FY 2017-18 and True Up for FY 2015-16. The Distribution Company, viz. **Noida Power Company Limited (NPCL)**, **Greater Noida** has filed Petition for Determination of Aggregate Revenue Requirement (ARR) / Tariff for FY 2018-19, Annual Performance Review for FY 2016-17, FY 2017-18 and True Up for FY 2016-17 before the **Uttar Pradesh Electricity Regulatory Commission (UPERC / Commission)**.

The **Commission** has admitted the same for State Distribution Companies and State Transmission Company vide its Orders dated November 12, 2018, for NPCL vide its Orders dated October 30, 2018, and for the further proceedings, proposes to hold combined “**Public Hearings**” for all the above licensees as per the schedule given below:
