ORDER

(DATE OF HEARING: 19.11.2024)

- 1. The petition has been filed under Regulation 5.4 of U.P. Electricity Regulatory Commission (Promotion of Green Energy through Renewable Purchase Obligation) Regulations, 2010 with the request to permit the Petitioner to carry forward the deficit in meeting the Renewable Purchase Obligations for F.Y. 2021-22 & 2022-23.
- 2. In its Order dated 04.11.2024, the Commission had directed the Petitioner to submit statement providing the complete details of the energy that has been procured through open access and accordingly year wise targets, RPO purchased and the

shortfall that is required to be fulfilled for the period from FY 2021-22 to FY 2023-24. Such statements were required to be duly certified by UP SLDC.

- 3. A written submission dated 18.11.2024 has been made by the Petitioner. According to the submission, made in pursuance of the Order of the Commission, the Petitioner has claimed to have submitted data and relevant documents clearly indicating month wise as well as annual consumption. It has also been submitted that the Petitioner has moved application for confirmation of the requirement of REC certificate before SLDC, which was claimed to be enclosed with the submission.
- 4. On perusal of the documents attached with the written submission, the Commission finds that the submission made by the Petitioner is not appropriate as the month wise quantum of energy shown in the statement does not correlate with the supporting documents that have been provided. Moreover, as submitted by the Petitioner, the application sent to SLDC for verification has also not been enclosed. Further, the statement submitted by the Petitioner has information only regarding FY 2021-22 and FY 2022-23 and no submission, whatsoever, has been made for FY 2023-24, in pursuance to the Commission's Order dated 04.11.2024.
 - 5. The Commission decides to implead SLDC in the matter and directs SLDC to verify the statement that has been submitted by the Petitioner and to provide their input, if any, in the matter. The Petitioner has also been directed to submit the data for FY 2023-24 and also establish direct co-relation of monthly energy consumption with the RPO targets furnished by the Petitioner. The Commission emphasized that the Petitioner can not obviate the responsibility of filing relevant data of energy consumption which is co-terminus with RPO targets and the achieved RPO status in its case.

6. The next date of hearing is scheduled on 30.01.2025.
