ORDER (DATE OF HEARING: 19.11.2024)

- 1. The Commission in its earlier Order dated 25.10.2024 noted the RPSCL's submissions that Steering Committee agreed to reconsider the exemption of Rosa TPP from mandatory use of STP water subject to inputs from National Mission for Clean Ganga and Urban Development department of state. Further, UPPCL requested for submissions on maintainability of instant Petition.
- 2. During the hearing today, Sh. Sumeet Notani, on behalf of RPSCL, submitted that Steering committee held its meeting with respect to State of Uttar Pradesh on 14.11.2024 and further they are still in the process of meeting with two-three states more before issuing any direction on the exemption issue regarding use of Sewage water. Further, Sh. Notani stated that approximately one month would be required to complete these consultations/meetings of Steering Committee with the States and therefore sought adjournment of the hearing. Counsel of UPPCL did not object to the RPSCL's request for adjournment.
- 3. After hearing the parties, the Commission adjourned the hearing on the Petitioner's request and directed to list the matter for next hearing on 30.01.2025.
