1. The Petitioner, UPPCL has filed this Petition seeking approval for SPPA dated 18.07.2024 pursuant to the Hon'ble National Company Law Tribunal Order dated 19.03.2024 for amalgamation of M/s TN Urja Private Ltd. with AGETTL (i.e., Respondent herein). The prayers of the Petitioner are as follows:







- a) Approve the Supplementary Power Purchase Agreement dated 18.07.2024, for Solar PV Power of 50 MW capacity from Okasa, Uttar Pradesh, between the Petitioner and AGETTL.
- b) Pass any further Order(s) as this Commission may deem fit in the facts and circumstances of the case.
- 2. During the hearing today, Sh. Divyanshu Bhatt, Counsel of UPPCL submitted that instant Petition was for approval of SPPA dated 18.07.2024 regarding change of name of the Solar PV based power generating company i.e., from M/s TN Urja Private Ltd. to M/s Adani Green Energy Twenty-Three Ltd. under the PPA dated 02.12.2015 for 50MW power project located at Okasa village, Jalaun (District) in the state of Uttar Pradesh.
- 3. After hearing, the Commission directed AGETTL to file its submission/objection, if any, before the next date of hearing.
